**BACKGROUND AND PROFESSIONAL QUALIFICATION OF
SUTHA KANDIAH (CHIEF FINANCIAL OFFICER)**

Sutha Kandiah is a seasoned finance executive with experience heading large institutional operations at UBS, as head of its Asian and Japanese capital markets businesses and head of Southeast Asian investment banking, and with building and operating start-up financial services businesses.

He brings over 25 years of experience in markets across Asia Pacific including Japan and has held leadership roles in the key finance hubs of Singapore, Hong Kong and Japan. He presently serves as Senior Advisor to a private equity firm and a venture capital firm that are focused on Southeast Asia and serves as advisor to the Board of Directors at Digipay, a digital payments and financial services application based in the Philippines.
